Executive Summary

As a municipal intern with the Borough of Ambridge in Beaver County, I led the development of a Walking Tour Application for the Ambridge Historic District.

Ambridge is an old and historic town first developed by the Harmonists, a German religious movement in the 1800s. Along with Old Economy Village, a museum and site that preserves the history and many of Ambridge's stories, various buildings and sites throughout the town retain the architecture and have a recorded history dating back centuries.

The application I developed, with help from the Borough, the Historic District, and technical advisors, aims to make the expansive history as accessible as possible. The app, named Ambridge Mobile, includes an expansive walking tour detailing the history of the town. It also includes many of the family-owned businesses, including restaurants, cafes, and breweries to help increase the overall exposure of the town.

With Ambridge having placed priority on modernizing, Ambridge Mobile helps the initiative and brings its history into the modern day.

Executive Summary

The Borough of Avalon is a small, historic community located just north of Pittsburgh. Primarily residential with a small business district, Avalon's walkable streets promote a family-friendly atmosphere.

During my internship, I contributed to projects supporting Avalon's values and goals. I created several user-friendly packets to guide residents through borough processes, such as packets for short-term rentals, fences, decks, and walls, and business resources. To support Avalon's goal to remain connected to the region, I drafted a formal letter to Pittsburgh Regional Transit opposing proposed bus route cuts. I also supported public education on stormwater management by building MS4 models to demonstrate runoff and nature-based solutions. These were showcased at the North Borough's Community Day and shared on the Borough's website.

To improve communication between residents and the borough, I created a borough contact sheet directing concerns to the appropriate staff. I also drafted a proposal for Avalon to adopt a 311-style citizen request system to promote accessibility and responsiveness.

Finally, I designed a survey distributed at Avalon's Sesquicentennial Celebration to gather community input as the borough awaits a state grant to fund the comprehensive plan. These projects reflect a commitment to government transparency, sustainability, and inclusivity in Avalon Borough.

This includes collaboration efforts with: Councils of Governments (COGs) to expand capacity, regionalization of the police force, the Local Government Academy (LGA) for a blight study, and Grounded for greenspace revitalization.

Executive Summary

Chartiers township is a small yet rapidly growing residential community located within Washington County. As a result of this growth, the township's database is not as up to date as needed for the census. In addition, several occupancy and tenant inspection policies needed reviewed and revised to better handle the townships' needs. Updating these databases and policies are essential for the township to regulate its growth.

As an intern at Chartiers Township, my first assignment was to update the Census database. The existing database was not maintained regularly. To ensure it could be used effectively for Census purposes, we chose to use sewer data and GIS data because they were updated annually therefore more reliable. I transferred relevant information from those databases into the original Census database to make it more up to date. Along with updating the current database, I researched ordinances and provided insight and suggestions to help improve them. I researched rental ordinances to try to find a solution for keeping track of rental properties and the tenants. This helps the township to be able to track all the residents in the township.

Before taking this role, I had very limited knowledge on how local government functions. As an intern and as a resident of Chartiers Township, I now feel that I have contributed to my community in a meaningful way.

Executive Summary

As a Township Manager Intern, I developed Excel and PowerBI tools to support staff in managing township operations. These tools focused on budget forecasting and expenditure analysis while remaining user-friendly.

For budgeting, I built an Excel model using statistical simulations and historical data to project the upcoming year's budget. I also created a PowerBI dashboard integrating GIS parcel data, tax records, zoning maps, and sewer infrastructure. This dashboard offers insights into land use, tax efficiency, and sewer ROI, helping forecast tax revenue based on future development.

On the expenditure side, I created Excel tools to analyze and forecast staffing and consulting costs. One model estimated police department expenses using officer start dates to project salary, longevity pay, and other costs. I also analyzed engineering consultant invoices, applying statistical simulations to identify cost trends and potential savings. This will support informed staffing and outsourcing decisions.

My internship at Collier Township provided valuable experience in municipal budgeting, data analysis, and operational planning. It strengthened my technical skills and deepened my understanding of local government. This opportunity was a pivotal step in my transition to a career in public sector management.





My internship with the Township of Pine through the Local Government Academy (LGA) has been incredibly enriching both personally and professionally. As Pine begins its Comprehensive Plan, I supported efforts to gather public input, modernize internal processes, and gain hands-on experience in local government operations.

Kirsten Primm played a key role in my internship. Her guidance helped me connect classroom concepts to real planning work. She consistently offered insight and support, and I learned so much from the way she approaches both policy and people.

One highlight was designing "The Pine Record Chart" a fun and interactive outreach activity at the Rock n Rec event. Residents ranked community priorities like walkability, parks, and sustainability, making public input more accessible and informative for future planning.

I truly got to experience a well-rounded view of how local government works by taking part in a variety of projects and day-to-day activities. Executive Summary

The principal assignment of my internship was an analysis of the feasibility and prospective township revenue of development along the Pennsylvania Turnpike 576. The project was divided into three primary phases each involving data collection, technical assumptions and qualitative assessments regarding efforts to rezone the Southern Beltway region pursuant to the comprehensive plan.

I examined possible correlations between neighborhood density and property tax to approximate which zoning district merited sustained application in future development; as the Southern Beltway region presents an array of impediments from topography to a deficit of utilities, it was imperative to consider flexible zoning. I further applied methodology similar to a land use assumption to determine new square footage able to be constructed along the Beltway, with the final objective to conceive a financial model depicting an exhaustive cost to the township.

The process enabled me to engage with a variety of township authorities, present findings to the board of commissioners and collaborate with the township engineers. Additionally, I assisted the township with implementing infrastructure improvements prescribed in the active transportation and comprehensive plans. Executive Summary

Tri-COG Land Bank seeks to address blighted property—a problem that degrades municipal tax bases and residential quality of life. The land bank has proven itself as an invaluable tool to restore blighted houses throughout Allegheny County and increasingly seeks to revitalize vacant lots. Vacant lots are costly to manage, and in Tri-COG's footprint, they have little economic value and their unsubsidized development into housing is economically infeasible.

My primary focus during my internship was to implement creative solutions to revitalize vacant lots. I conducted a cost-benefit analysis for planting turfgrass alternatives on vacant land bank lots, leading to a pilot program where a clover seed mixture will be planted on the land bank's next three open lots. I built an interactive app, using GIS, that in partnership with PA Solar Center enabled the land bank to identify facilities that can be powered with solar panels stationed on nearby vacant lots. To empower community-led revitalization of neglected land, I drafted practitioner-informed policy and documents to create capacity for urban gardening on land bank lots.

When not working with vacant land, I was writing grants for Steel Rivers COG and assisting in the acquisition and disposition of houses. I am appreciative of my internship for teaching me the technical processes in land banking, grant writing, and policy.



Executive Summary

A Council of Governments works to aid its member towns in various ways, one of which is to increase employee capacity by taking on some of the tasks within the municipal office. The Turtle Creek Valley Council of Governments (TCVCOG) accomplishes this by taking on utility billing, grant administration, and code enforcement for various towns in membership. During my time at the TCVCOG, I have had many opportunities to experience how a municipal authority works to aid and protect the residents of its member towns - for which I am most grateful.

In order to efficiently, effectively manage the code enforcement for four of its member towns, the TCVCOG developed their own database for tracking inspections, violations, citations, and more: CodeNForce.

This database has been at the center of my focus while at the TCVCOG. As we work to grow the usage of CodeNForce throughout the region, code enforcement officers and town administrators need assistance learning how to use the system. I help refine this process by creating tutorial videos that detail how to use the different functions within the system. For example, I have created videos on how to open inspections on the mobile app, how to link people to mailing addresses, how to generate letters of violation, and more.

All of these functions work together so that an officer can keep all of the information about a property in one place. Enforcing code violations helps to mitigate blight in communities as well as protect renters from landlords who might let their houses fall into disrepair, disregarding the families living inside. As a non-profit organization, the TCVCOG is continuously working to keep communities healthy and thriving - a goal I am happy to share.



Wilkins Township, a close-knit community near Pittsburgh with over 6,000 residents, is planning to replace its municipal building, which was constructed in 1957 and no longer meets modern accessibility, security, or operational standards. As a Community Outreach Specialist, I facilitated communication between the Township Board, residents, and experts to guide this critical project.

My internship began with assessing the municipal building's deficiencies, reviewing the 2023 McKim & Creed feasibility study, and researching municipal bonds and financing options. This foundation allowed me to translate complex technical and financial details into accessible information for the public, ensuring effective community outreach.

To promote transparency, I developed a project timeline for the Township's website and created a community feedback survey, which gathered over 125 responses through election-day outreach, local events, and meetings. I presented the results in clear graphs to amplify community voices.
